### Brief Overnight Closures on I-95 North Ramps Next Week

**St. Augustine, Fla.** – The Florida Department of Transportation (FDOT) will temporarily close the I-95 northbound entrance and exit ramps at U.S. 1, the I-95 northbound rest area (mile marker 302) and State Road 206 next week, weather and schedule permitting.

These brief overnight rolling closures will allow crews to safely resurface the right lane of I-95 northbound within the project area. Electronic message boards will alert drivers of the closure. Drivers are encouraged to use FL511.com and plan ahead.

#### U.S. 1:

The I-95 northbound exit ramp to U.S. 1 and the I-95 entrance ramp from U.S. 1 are expected to be temporarily closed for approximately four hours sometime between 7 p.m. and 7 a.m. Sunday, September 20 and Monday, September 21, weather and schedule permitting.

As shown in the map below, drivers attempting to exit I-95 northbound at U.S. 1 will be detoured north to the State Road 206 exit back onto I-95 southbound, where they can access U.S. 1.

Drivers attempting to enter I-95 northbound from U.S. 1 will be detoured onto I-95 southbound to the Matanzas Woods Parkway exit, where they can access I-95 northbound.

### I-95 Northbound Rest Area:

The ramp to the I-95 northbound rest area south of State Route 206 (mile marker 302) is expected to be temporarily closed for approximately four hours sometime between 7 p.m. and 7 a.m. on Monday, September 21, weather and schedule permitting. The next rest area is located 29 miles north of the closure at mile marker 331.

### State Road 206:

The I-95 northbound exit ramp to State Road 206 and the I-95 entrance ramp from State Road 206 are expected to be temporarily closed for approximately four hours sometime between 7 p.m. and 7 a.m. Wednesday, September 23 and Thursday, September 24, weather and schedule permitting.

As shown in the map below, drivers attempting to exit from I-95 northbound at State Road 206 will be detoured north to the State Road 207 exit back onto I-95 southbound, where they can access State Road 206.

Drivers attempting to enter I-95 northbound from State Road 206 will be detoured onto I-95 southbound to the U.S. 1 exit, where they can access I-95 northbound.



The work is part of FDOT's I-95 resurfacing project in St. Johns County, which consists of milling and resurfacing both directions of I-95 from the Flagler County line to just south of State Road 207, including the interstate entrance and exit ramps for State Road 206 and U.S. 1.

Hubbard Construction is expected to complete the \$22.6 million project in fall 2022, weather and schedule permitting.
