Detours Scheduled from March 9 to March 13 as Part of FDOT's I-10 Widening Project

JACKSONVILLE, Fla. – As part of FDOT's I-10 from I-295 to I-95 widening project, closures and detours are scheduled at multiple interchanges within the project limits Sunday, March 9 through Thursday, March 13 while crews perform construction work and traffic shifts, weather and unforeseen circumstances permitting. Please note that schedules may be adjusted to avoid conflicting detour traffic along the routes.

Closure scheduled Sunday, March 9 and Monday, March 10 from 10 p.m. to 5 a.m.:

- **Irene Street on-ramp to I-10 West closed:** Drivers will detour to Edison Avenue and take Forest Street to connect with I-10 West.

Closure scheduled Sunday, March 9 and Wednesday, March 12 from 10 p.m. to 5 a.m. If either night is impacted by weather, the closure will be implemented the following night:

- **I-10 West at Lane Avenue closed:** Drivers will detour north on Lane Avenue, left on Commonwealth Avenue and south on I-295 to access I-10.

Closures scheduled Tuesday, March 11 from 10 p.m. to 5 a.m. the following morning:

- **I-10 West Off-Ramp to Lane Avenue closed:** Drivers will detour to I-295 North to Commonwealth Avenue, access I-295 South to I-10 East and exit Lane Avenue.
- **U.S. 17 (Roosevelt Boulevard) on-ramp to I-10 East closed:** Drivers will detour on Roosevelt Boulevard to McDuff Avenue north to access I-10 East.
- **I-10 West exit to U.S. 17 (Roosevelt Boulevard) closed:** Drivers will detour to the McDuff Avenue exit and make a left on McDuff Avenue to connect with U.S. 17.

Closure scheduled Wednesday, March 12 and Thursday, March 13 from 10 p.m. to 5 a.m. the following morning:

- **Lane Avenue On-Ramp to I-10 West closed:** Southbound Lane Avenue drivers will detour to Normandy Boulevard to I-295 North and access I-10. Northbound Lane Avenue drivers will continue to Commonwealth Avenue to I-295 to access I-10.

Closure scheduled Thursday, March 13 from 10 p.m. to 5 a.m. the following morning:

- **I-10 East exit to McDuff Avenue closed:** Drivers will detour to the Stockton Street exit, right on Stockton Street, right on Irene Street, to I-10 west to McDuff Avenue.

FDOT hired Superior Construction to complete this \$174.5 million project in summer 2025, weather and unforeseen circumstances permitting.
