### **FDOT to Host Dec. 10 Hybrid Construction Open House for First Coast Expressway in St. Johns County**

*Work on the \$242.6 million project began last month*

**ST. JOHNS COUNTY, Fla.** – FDOT will host a hybrid construction open house next week for the first segment of the First Coast Expressway in St. Johns County.

Interested parties may drop by the Renaissance World Golf Village, 500 South Legacy Trail, St. Augustine, FL 32092 anytime between 4:30 and 6:30 p.m. on Tuesday, Dec. 10. Attendees will have the opportunity to view displays, ask questions and speak with members of the project team.

Work began last month on the First Coast Expressway (State Road 23) from east of County Road 16A to east of County Road 2209 (St. Johns Parkway).

De Moya Asphalt Joint Venture was awarded the contract for this \$242.6 million project, which includes construction of approximately 4.3 miles of a new four-lane limited-access toll facility, milling and resurfacing, earthwork, subsoil excavation, base work, shoulder treatment, drainage improvements, curb and gutter, traffic signals, lighting, highway signing, guardrail, box culverts, bridges, MSE walls, sidewalks/bicycle path, intelligent transportation systems (ITS), tolling, and other incidental construction. The project is estimated for completion in 2030, weather and unforeseen circumstances permitting.
