### **ICYMI: FDOT to Host Public Meeting for S.R. A1A (Avenida Menendez) at S.R. 5 (King Street/Cathedral Place) Intersection Improvement**

**JACKSONVILLE, Fla.** – FDOT will hold a public meeting Wednesday, Nov. 8, 2023 to discuss proposed changes to the intersection of State Road A1A (Avenida Menendez) at State Road 5A (King Street/Cathedral Place) in St. Augustine.

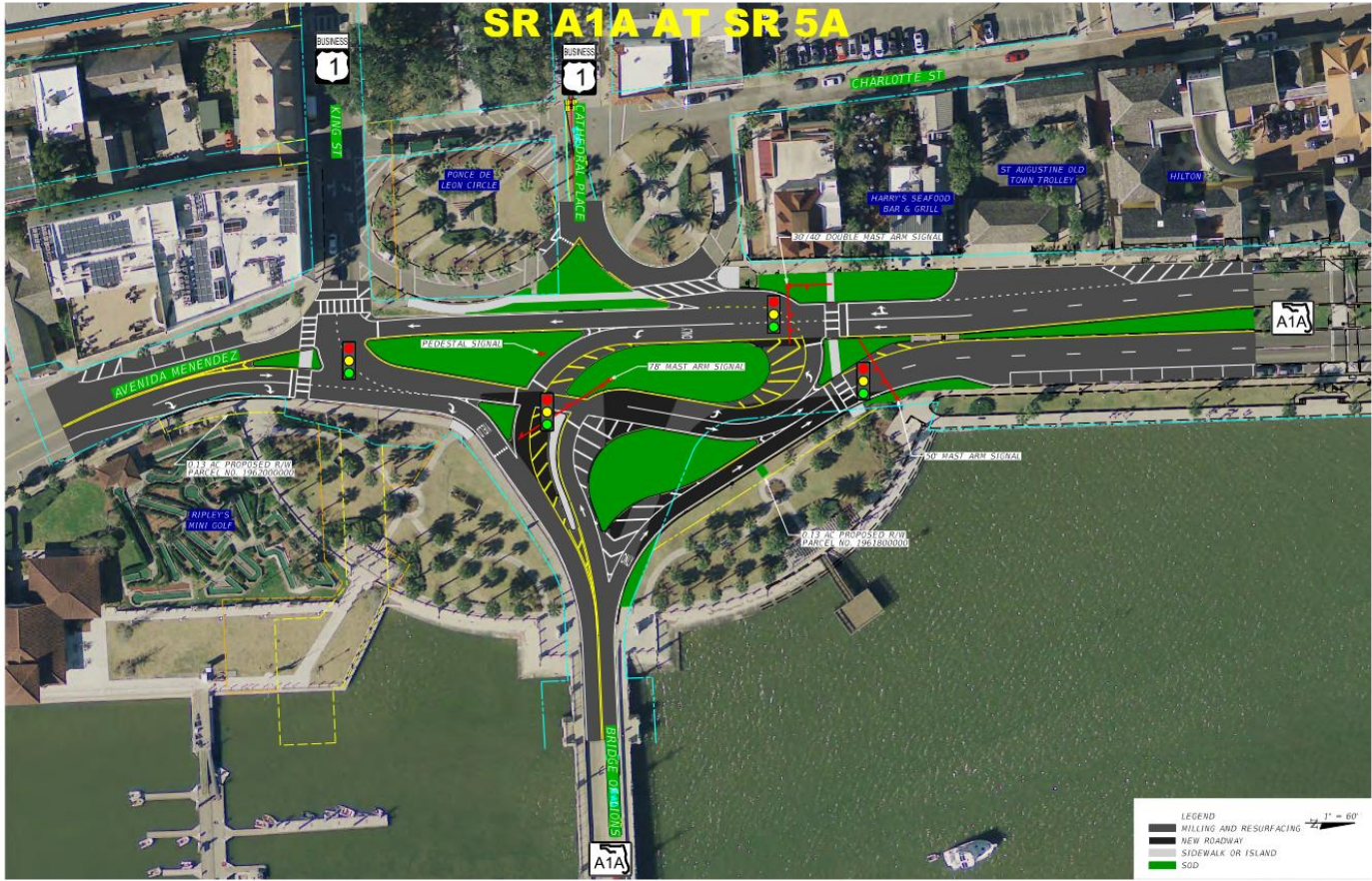
Proposed improvements include converting the existing intersection of State Road A1A (Avenida Menendez) at State Road 5A (King Street/Cathedral Place) into an innovative configuration designed to provide safer and more efficient traffic movement throughout the intersection.

The meeting will take place virtually and in-person at **St. Augustine City Hall, Alcazar Room, 75 King Street, St. Augustine, FL 32084**. FDOT staff and consultants will be available from 4:30 to 6 p.m. to answer questions and accept comments. A formal hearing and public comment period will begin at 6 p.m.
