### Multiple Overnight Detours Planned for the I-10/I-95 Interchange Improvements Project

**Jacksonville, Fla.** – As part of FDOT’s I-10/I-95 Operational Improvements project, multiple overnight detours are scheduled Tuesday, June 9 through Sunday, June 14 for bridge construction activities, weather and unforeseen circumstances permitting.

**I-95 South Detour:** June 9-11 from 10 p.m. to 6 a.m., drivers on I-95 south will be detoured to the Forest Street exit, where they will turn left on Forest Street, left on Riverside Avenue and onto the Acosta Bridge where traffic can rejoin I-95 south. (See map below)

**I-10 to I-95 South Detour:** June 9-11 from 10 p.m. to 6 a.m., drivers on I-10 who wish to take I-95 south will be detoured north at the I-95 interchange to the Forest Street exit, where they will turn right on Forest Street, left on Riverside Avenue and onto the Acosta Bridge where traffic can rejoin I-95 south. (See map below)

**I-10 to I-95 South Alternate Detour:** June 9-11 from 10 p.m. to 6 a.m., drivers on I-10 east who wish to take I-95 south may also take I-95 north to the Union Street exit, where they will turn right on North Jefferson Street and onto the Acosta Bridge to rejoin I-95 south. (See map below)

**I-95 North to I-10 Flyover Detour:** June 11-14 from 10 p.m. to 6 a.m., motorists using I-95 north who wish to connect to I-10 west will be detoured to the Park Street exit. At the bottom of the ramp, drivers will turn right onto Park Street, left onto Forest Street, left on Edison Avenue, left on Stockton Street and left on Irene Street to access the I-10 west ramp. (See map below)



**Stockton Street On-Ramp at I-10 Detour:** June 12 from 10 p.m. to 6 a.m., motorists using Stockton Street to connect to I-10 east will be detoured north on Stockton Street, right on Edison Avenue and right on Forest Street to connect to I-95 north. Motorists who wish to take I-95 south will continue on Forest Street and turn right on Park Street to connect to I-95 south. (See map below)

**I-10 East Exit to Stockton Street Detour:** June 12 from 10 p.m. to 6 a.m., motorists on I-10 east who wish to take the Stockton Street exit will be detoured at the McDuff Avenue exit, turn left on McDuff Avenue and turn right on Edison Avenue to connect to Stockton Street. (See map below)

**Roosevelt Boulevard Detour:** June 12 from 10 p.m. to 6 a.m., motorists on Roosevelt Boulevard north (U.S. 17) will be detoured to McDuff Avenue north, right on Edison Avenue and right on Forest Street to connect to I-95 north. Motorists who wish to take I-95 south will continue to Park Street and turn right to connect to I-95 south. (See map below)

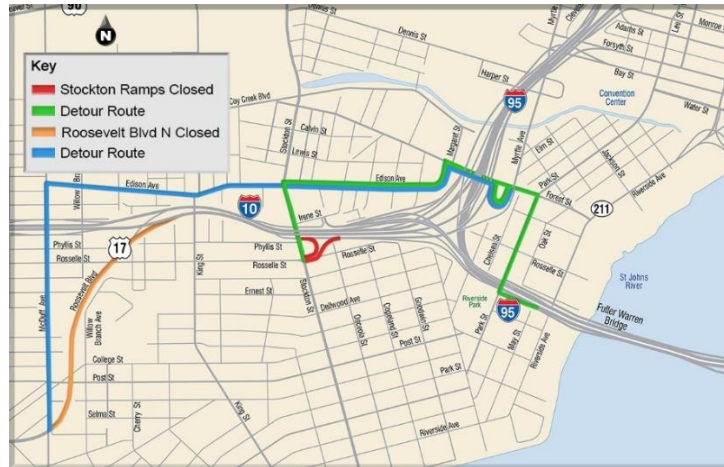

**I-10 East Detour:** June 13 from 10 p.m. to 6 a.m., motorists traveling east on I-10 will be detoured at the McDuff Avenue exit. Motorists who wish to continue to I-95 will turn left on McDuff Avenue north, right on Beaver Street east and continue to I-95. (See map below)
