
CR 220 / Henley Road Quadrant Intersection Concept



The CR 220 / Henley Road Quadrant Intersection Concept would relocate the westbound left turn lanes from the CR 220 / Henley Road intersection to the CR 220 / Rideout Ferry Road intersection (shown as blue arrows) and relocate the eastbound left turn lanes to the Henley Road / Aspen Forest Drive intersection (shown as red arrows). The proposed changes would reduce the amount of time motorists have to wait at the CR 220 / Henley Road intersection.

Welcome to the Subsequent Public Hearing

The Florida Department of Transportation (FDOT), District Two welcomes you to a Subsequent Public Hearing regarding the proposed improvements to County Road (CR) 220 from Henley Road to Knight Boxx Road in Clay County, Florida. The FDOT is conducting a Project Development and Environment (PD&E) Study to evaluate alternatives to enhance safety and provide additional capacity to meet existing and future traffic demand on CR 220. The alternatives being considered include the No-Build (or do nothing) Alternative and Widening Alternative (widen CR 220 to four lanes). Tonight's Subsequent Public Hearing includes changes made to the CR 220/Henley Road intersection as part of the Widening Alternative that have taken place since the April 2018 Public Hearing. The No-Build (or do nothing) Alternative also remains under consideration.
