The Florida Department of Transportation (FDOT) and the City of Gainesville invites you to attend the Public Hearing for the proposed improvements to SW 62nd Blvd from SW 43rd Street/Clark Butler Boulevard to SW 52nd Street, Financial Management Number 211365-6-22-01 in Alachua County, Florida. **The public hearing will be held on Thursday, April 12, 2018 at Doubletree by Hilton Gainesville—Gator Room, 3726 SW 40th Boulevard, Gainesville, FL 32608.** The hearing will begin at 4:30 pm to give you an opportunity to review the exhibits and talk one-on-one with FDOT staff. A formal presentation will take place at 6:30 pm followed by a public comment period.

The FDOT is conducting a Project Development and Environment (PD&E) Study to reduce congestion by providing an additional north-south roadway connecting SW Archer Road to SW 20th Avenue. FDOT encourages you to get involved throughout the study by providing comments, concerns, questions and/or suggestions to the Study Team.
