ABOUTTHE PROJECT

The Florida Department of Transportation is scheduled to begin this roadway improvement project in April 2022 with an expected completion in summer 2024, barring unforeseen circumstances. This \$30 million project includes resurfacing SR 116 from east of I-295 at Merrill Road to west of A1A at Wonderwood Drive. It also includes:

- Repairing curb and gutter.
- Replacing drainage pipes between Gately and Girvin roads.
- Resurfacing bridge approaches at Jones Creek, Ginhouse Creek, Mt. Pleasant Creek and the Intracoastal Waterway bridges.
- Installing brighter street lights and installing countdown pedestrian signals at 9 intersections:

Wompi Drive

Ft. Caroline Road East

Ft. Caroline Road West

St. Johns Bluff Road

Monument Road

Kernan Boulevard

Mt. Pleasant Rd at Longleaf Pine Way

Gately Road

Girvin Road


ABOUTTHE PROJECT

Work will be broken down into 5 roadway segments

- Jane Street to Ginhouse Creek Bridge
- Ginhouse Creek Bridge to East of St. Johns Bluff Road
- East of St. Johns Bluff Road to east of Derringer Road
- East of Derringer Road to West of Monument Road
- West of Monument Road to Sand Castle Lane

Work on the 5 roadway segments will occur in 3 phases


- Work per each ½ mile to 4 ½ mile segment will last 4 to 10 months.
- Single lane closures will be in effect during construction of each segment.
- Segment work will not occur adjacent to each other.



ABOUT THE PROJECT - Phase 1 Construction

Phase 1 Two segments under construction:


- East of St. Johns Bluff Road to east of Derringer Road (2/3 mile)
- West of Monument Road to Sand Castle Lane (4 ½ miles)



ABOUT THE PROJECT - Phase 2 Construction

Phase 2 One segments under construction:

• Ginhouse Creek Bridge to east of St. Johns Bluff Rd. (2/3 mile)



ABOUT THE PROJECT - Phase 3 Construction

Phase 3 Two segments under construction:

- Jane Street to Ginhouse Creek Bridge (1 mile)
- East of Derringer Road to west of Monument Road (½ mile)
