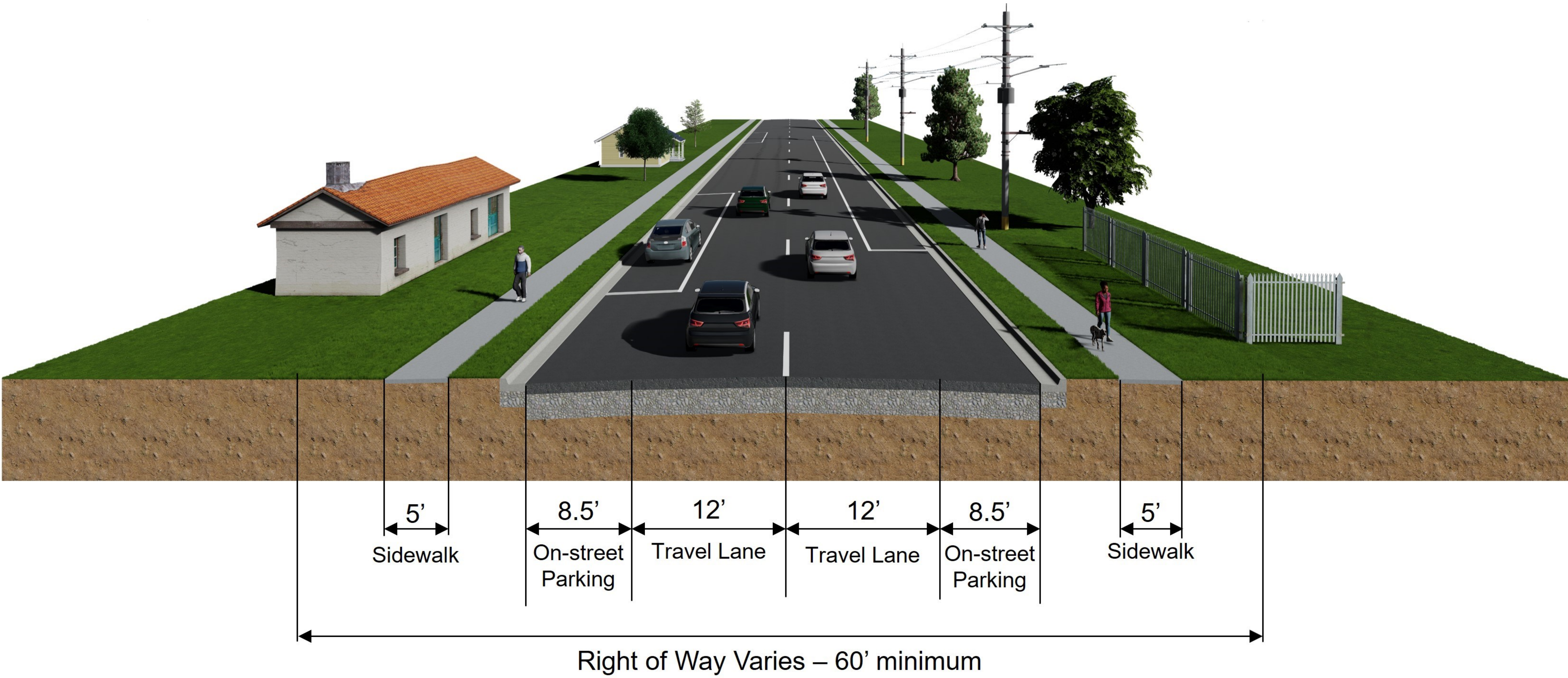

PROJECT LOCATION MAP



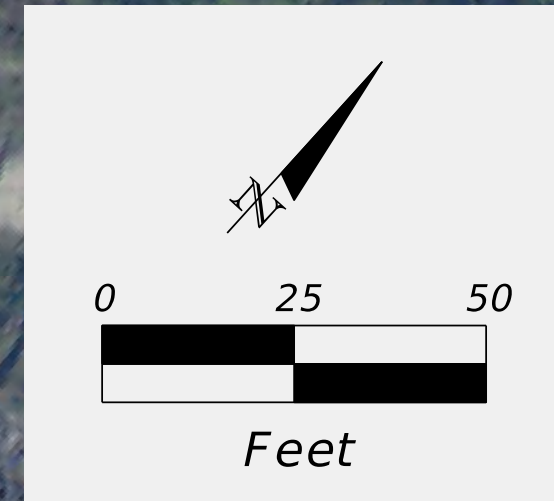
PROPOSED TYPICAL SECTION

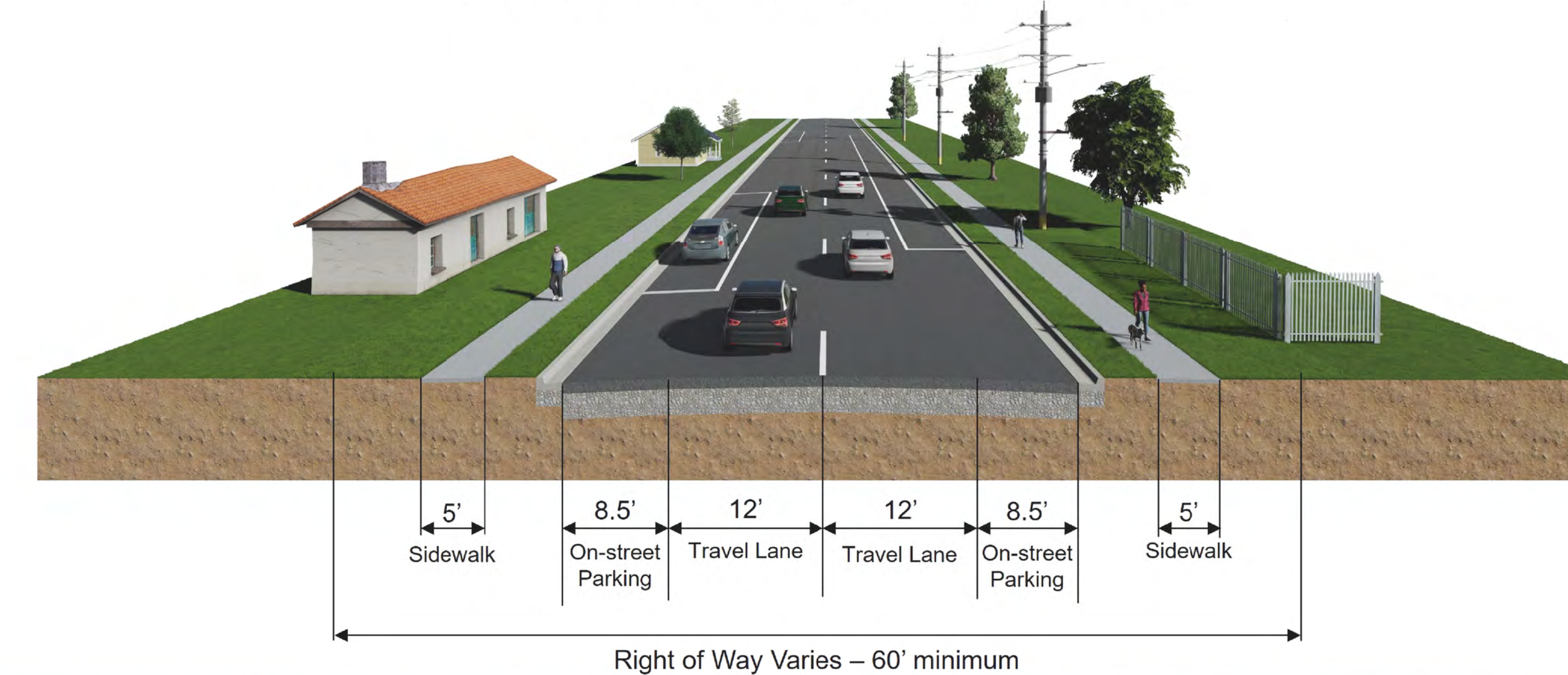

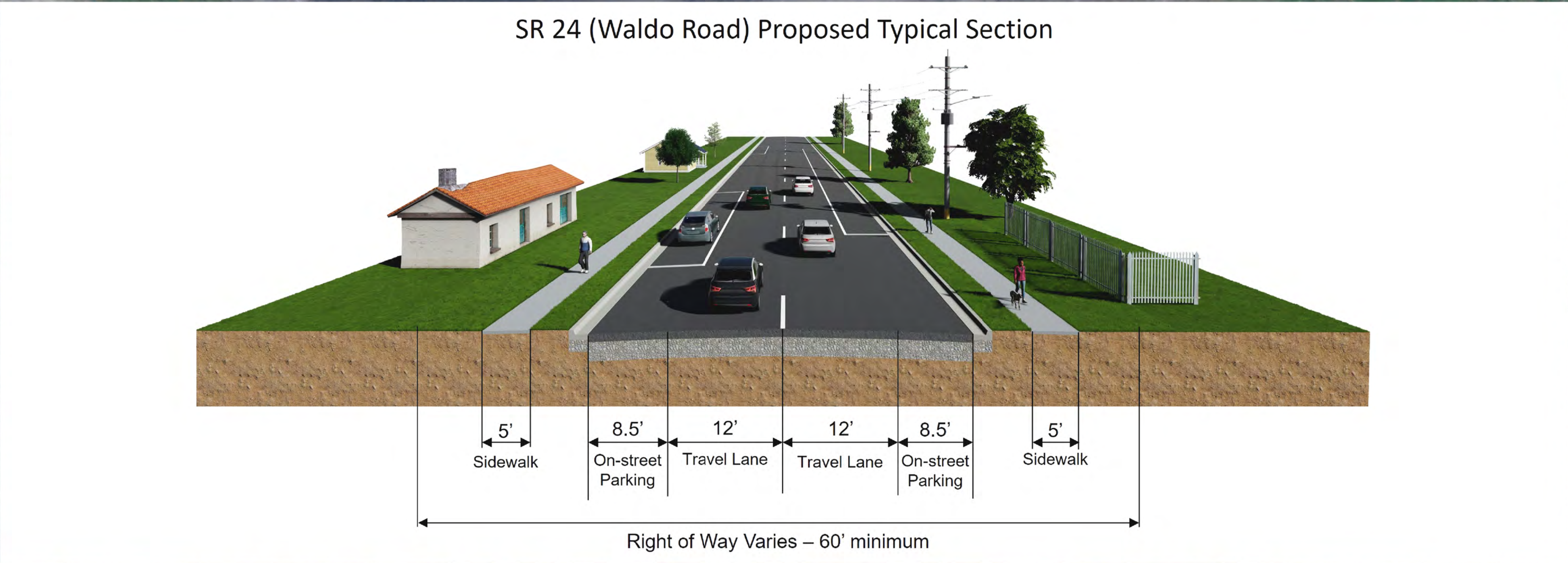


SR 24 (Waldo Road) Proposed Typical Section



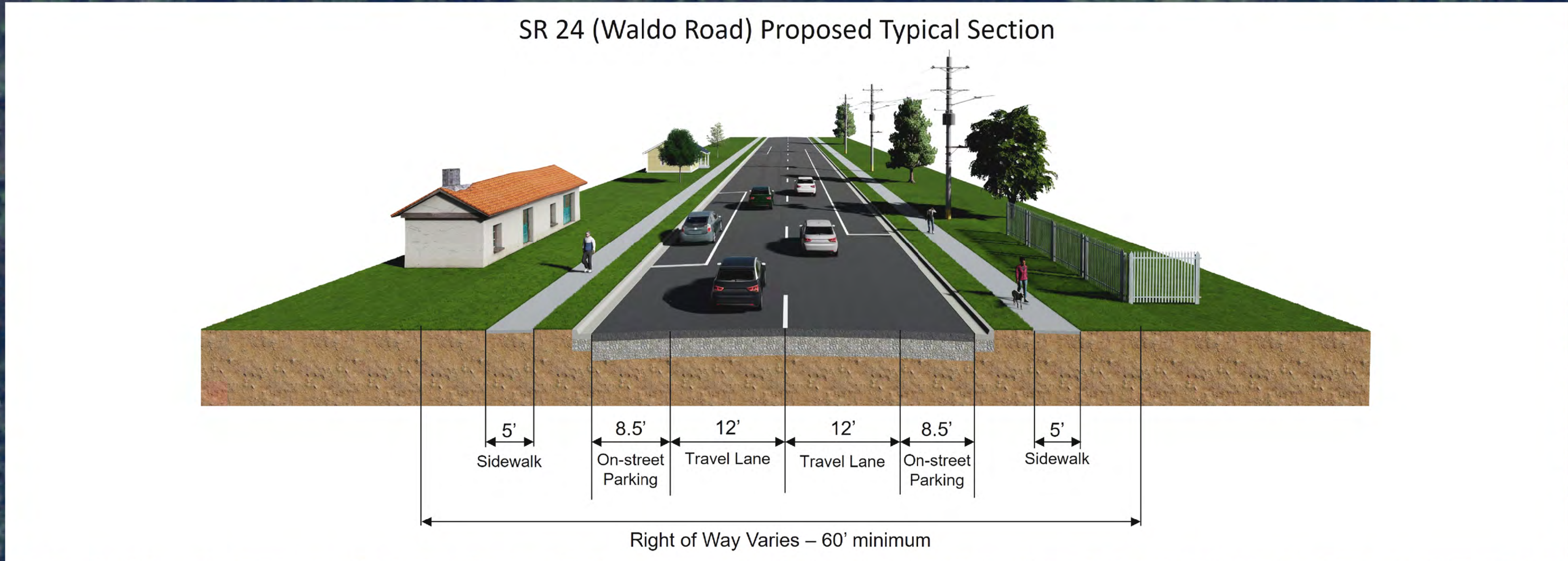
