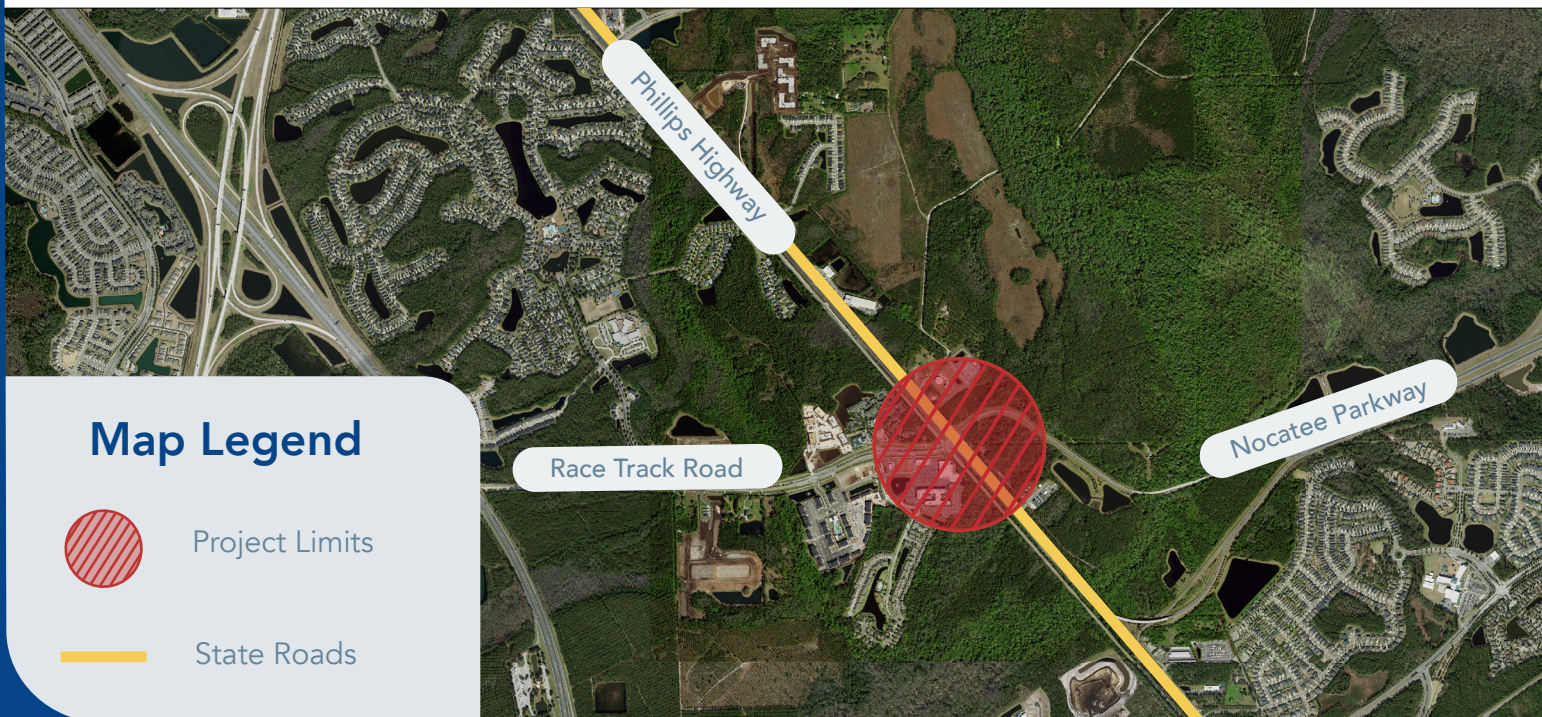
Map Legend



Project Limits

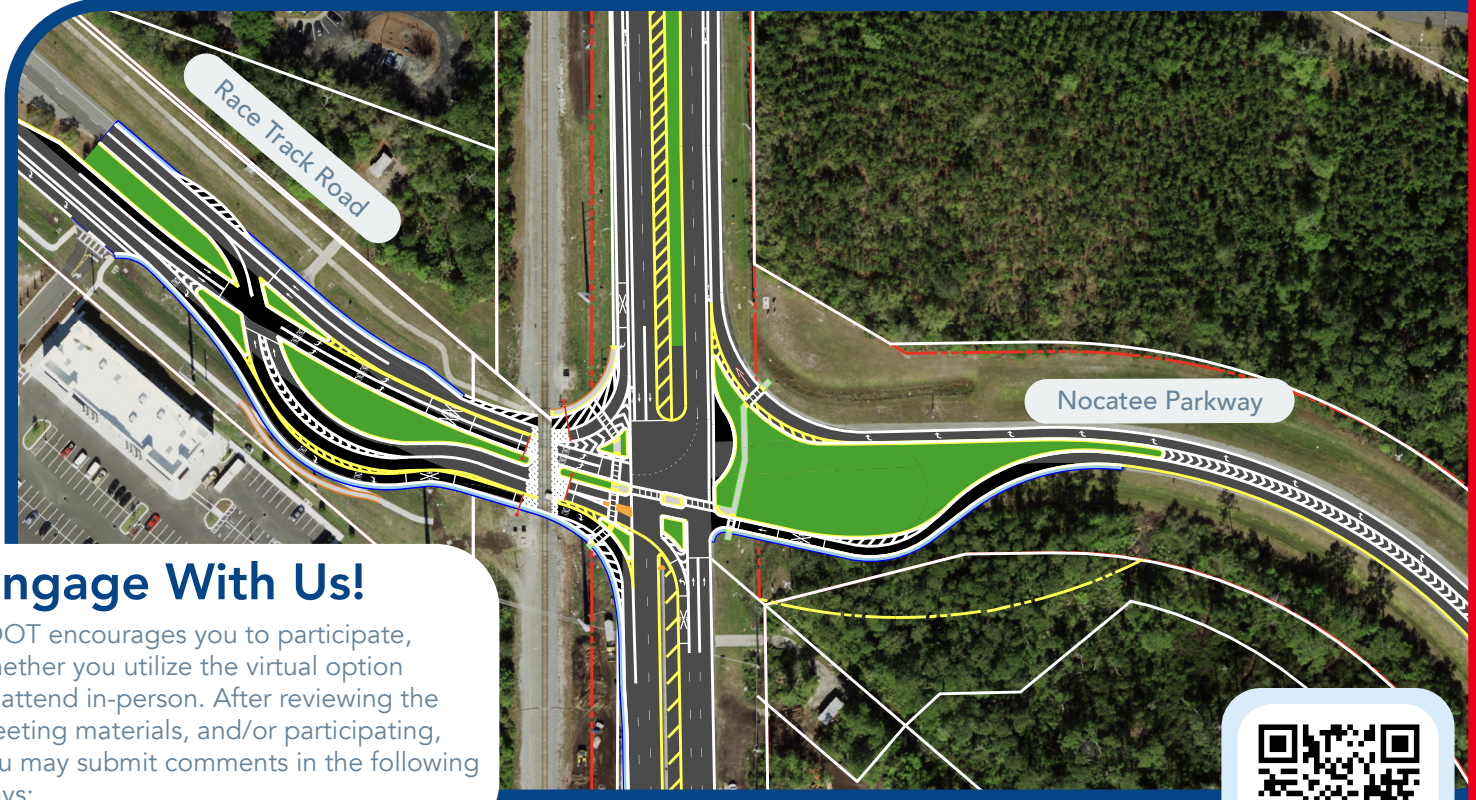

A Project Development & Environment (PD&E) Study is currently underway to evaluate alternatives to address traffic operations and safety improvements at the intersection of Race Track Road/Nocatee Parkway and US 1 (Philips Hwy). The proposed concept being presented will reduce the delay for motorists traveling through the intersection.
