Detours Scheduled for Next Week as Part of FDOT's I-10 Widening Project

JACKSONVILLE, Fla. – As part of FDOT's I-10 from I-295 to I-95 widening project, closures and detours are scheduled at multiple interchanges within the project limits beginning Sunday, July 21 while crews perform bridge construction operations, weather and unforeseen circumstances permitting.

Closure scheduled Sunday, July 21 from 10 p.m. to 5 a.m. the following morning:

- **I-10 West exit to Luna Street:** Drivers will detour to the Cassat Avenue exit and take Highway Avenue to connect with Luna Street.

Closure scheduled Sunday, July 21 through Tuesday, July 23 from 10 p.m. to 5 a.m. the following morning:

- **I-10 East exit to Cassat Avenue closed:** Drivers will detour to McDuff Avenue and take Lenox Avenue to connect with Cassat Avenue.

Closures scheduled Sunday, July 21 through Thursday, July 25 from 10 p.m. to 5 a.m. the following morning:

- **I-10 West exit to U.S. 17 (Roosevelt Boulevard) closed:** Drivers will detour to the McDuff Avenue exit and turn left on McDuff Avenue to connect with Roosevelt Boulevard.

Closures scheduled Monday, July 22 and Wednesday, July 23 from 10 p.m. to 5 a.m. the following morning:

- **I-10 West exit to Cassat Avenue closed:** Drivers will detour to Lane Avenue and take Highway Avenue to connect with Cassat Avenue.
- **Cassat Avenue to I-10 on-ramp closed:** Northbound drivers will detour to Highway Avenue and take Lane Avenue to connect with I-10. Southbound drivers will detour to Lenox Avenue, to Normandy Avenue and take Lane Avenue to connect with I-10.

Closure scheduled Tuesday, July 23 through Thursday, July 25 from 10 p.m. to 5 a.m. the following morning:

- **I-10 West exit to Lane Avenue closed:** Drivers will detour to I-295 and take Commonwealth Avenue to connect with Lane Avenue.

FDOT hired Superior Construction to complete this \$174.5 million project in summer 2025, weather and unforeseen circumstances permitting.
