Intersection Improvements at S.R. 207 and Cracker Swamp Road Scheduled to Begin Next Week

EAST PALATKA, Fla. – The Florida Department of Transportation (FDOT) is scheduled to begin a safety improvement project on State Road 207 at Cracker Swamp Road September 7, weather and schedule permitting.

The intersection improvements will include minor drainage work, turn lane widening on Cracker Swamp Road, roadway milling and resurfacing, and the installation of red flashing beacons on the top of stop signs at the intersection for added visibility and safety.

To safely complete milling and paving operations, detours will be necessary. No lane closures will be allowed from 6:30 a.m. to 9 a.m. and 3 p.m. to 7 p.m. Monday through Friday.

P& S Paving, Inc. is estimated to complete the \$435,000 improvement project by early 2023. Construction completion estimates are fluid and subject to change, weather and schedule permitting.

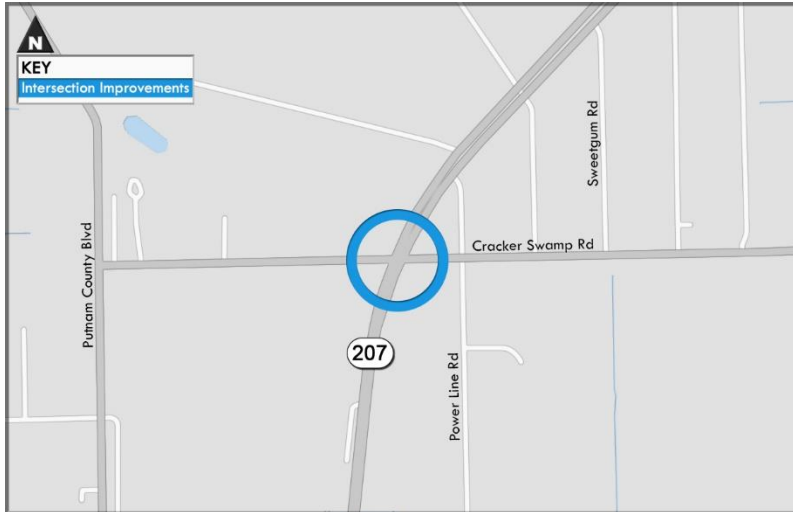
