

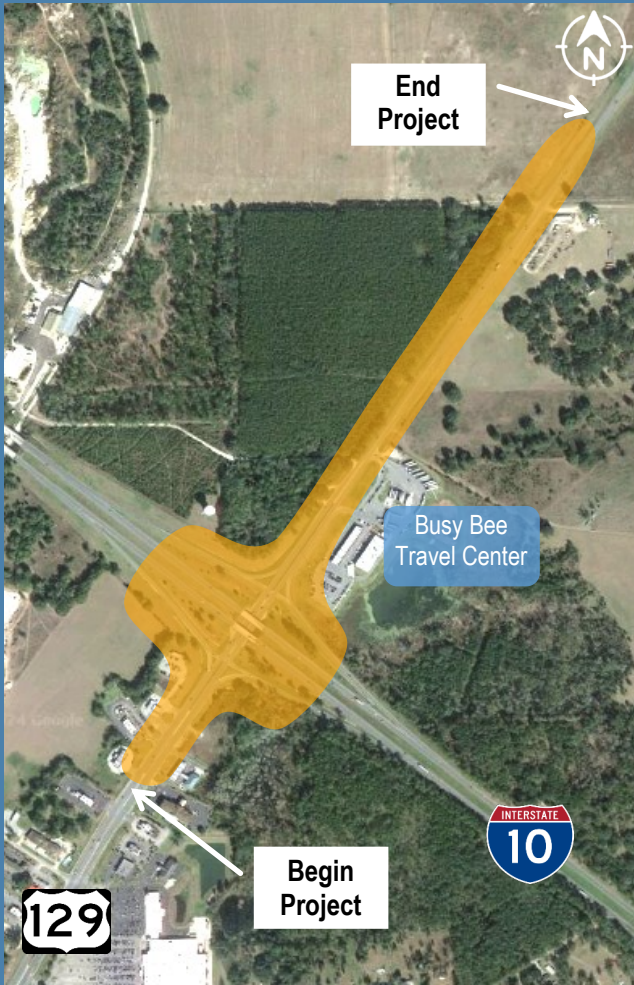
# I-10 AT US 129 OPERATIONAL IMPROVEMENTS

### INTRODUCTION

The Florida Department of Transportation (FDOT) District Two invites you to the Hybrid Public Meeting for the I-10 at US 129 Operational Improvements project (Financial Management No. 443239-1) in Suwannee County, Florida. This meeting will inform the public of the proposed improvements and will serve as an official forum providing an opportunity for the public to express their opinions and concerns regarding the project.

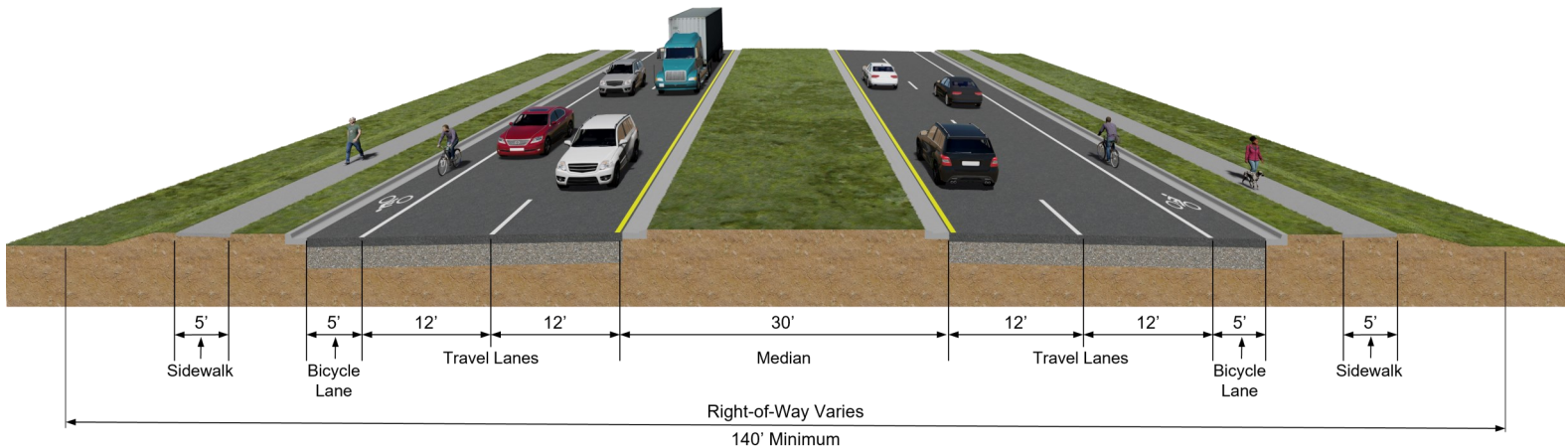
### ABOUT THE PROJECT

The project proposes operational improvements for the I-10 at US 129 interchange and access management improvements on US 129 north and south of the interchange. Additional improvements include:

- Widening US 129 from two to four lanes from north of the interchange to approximately 1,500-feet north of the Busy Bee Travel Center/Marathon Driveway
- Installing traffic signals at the interchange ramps and at the north entrance of the Busy Bee Travel Center
- Adding dual left-turns at the northbound and southbound off-ramps
- Extending the existing sidewalk and adding a bicycle lane through the interchange while providing ADA compliant pedestrian features at the ramps and crossings

### TYPICAL SECTION

US 129 is proposed to be widened to include four 12-foot lanes, two in each direction, with a five-foot bicycle lane and a five-foot sidewalk on both sides of the road. See the proposed typical section below:

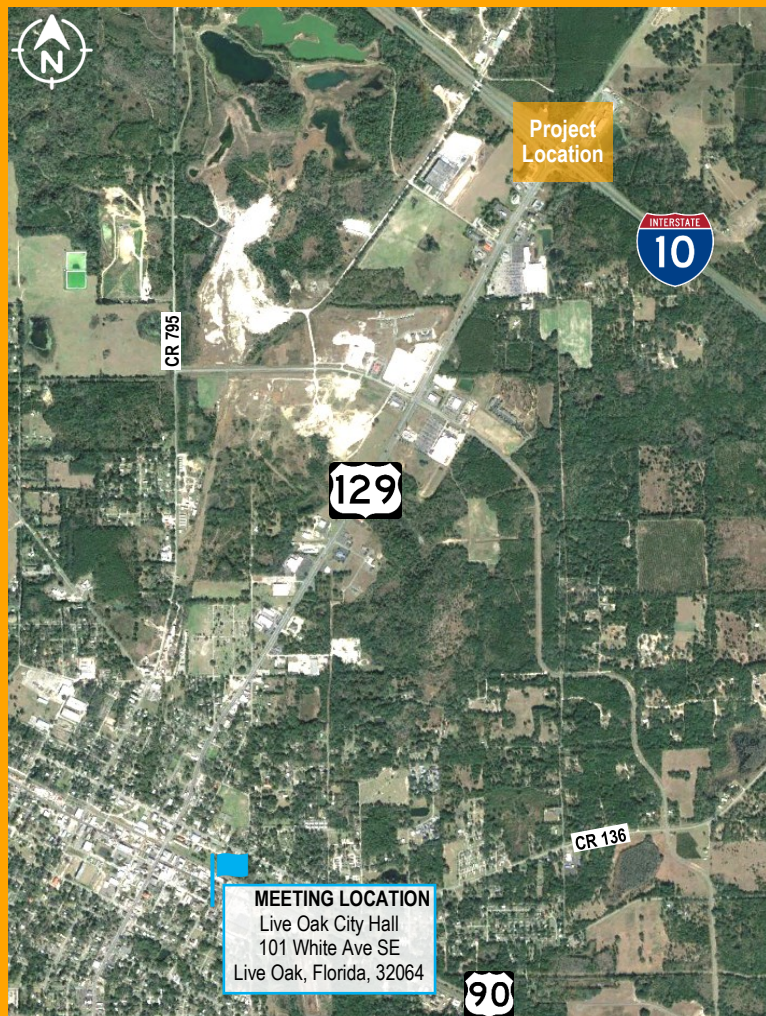

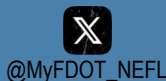
