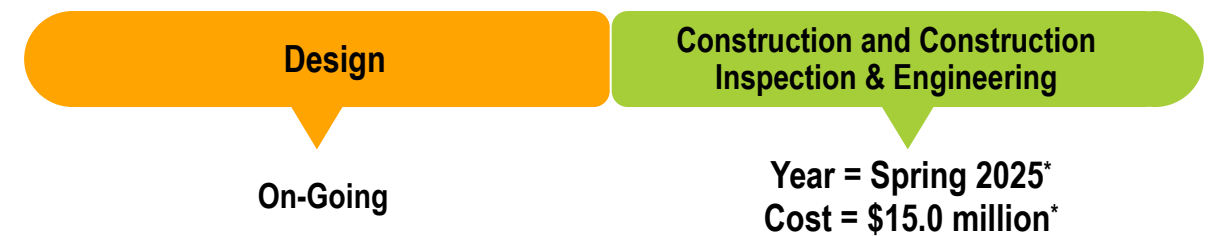

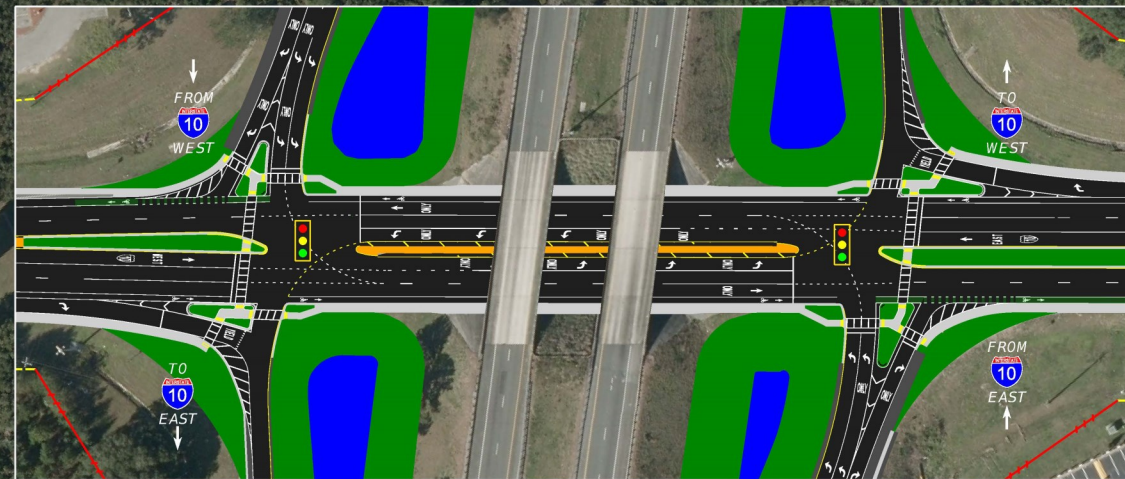

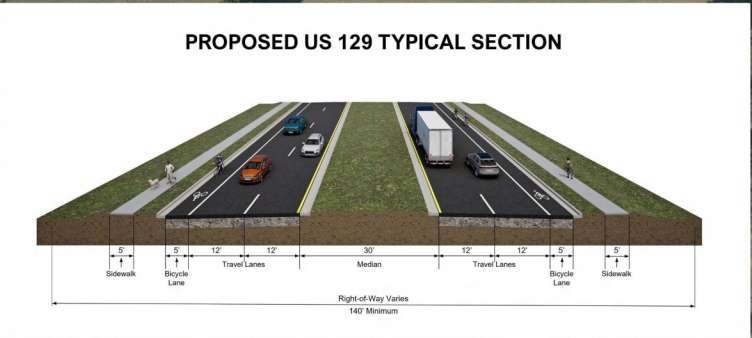


**PROPOSED US 129 TYPICAL SECTION UNDER I-10 BRIDGE**

**I-10 AT US 129 OPERATIONAL IMPROVEMENTS  
FINANCIAL MANAGEMENT NO. 443239-1  
SUWANNEE COUNTY, FLORIDA**

**KEY PROJECT IMPROVEMENTS**

- The project proposes safety and operational improvements for the I-10 at US 129 interchange and along US 129. Additionally, access management changes are proposed along US 129. The improvements include:
- Signalizing the I-10/US 129 off-ramp intersections
  - Adding a left-turn lane at both the eastbound and westbound I-10 off-ramps
  - Extending the right-turn lane at the I-10 westbound on-ramp, the left- and right-turn storage lanes at the eastbound and westbound off-ramps, and the left-turn lanes on US 129 in both the northbound and southbound directions
  - Widening US 129 from two to four lanes from north of the interchange to the Busy Bee Travel Center north entrance
  - Signalizing the north entrance of the Busy Bee Travel Center
  - Adding sidewalks and bicycle lanes on US 129 within the project limits
