Improving Safety while Respecting Environmental, Cultural and Historical Considerations

Based on FDOT's respect for, and commitment to historic resources, a Cultural Resource Assessment Survey (CRAS) was conducted to determine the significance of the sidewalk to the Fernandina Beach Historic District and its eligibility for inclusion in the National Register for Historic Places (NHRP). The approach was developed through consultation and coordination with the City of Fernandina Beach and the State Division of Historical Resources.






