

# **Project Location Map**




# **Right-of-Way**

The Proposed Main Street bridge project will be constructed within City right of way. This project will not cause any relocation of families or businesses. All right of way acquisition will be conducted in accordance with Florida Statute section 339.09 and section 421.55 and also the Federal Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, commonly known as the Uniform Act.

## **About the Project**

Constructed in 1950, the existing Main Street bridge over Pimple Creek is a two-lane bridge comprised of a prestressed concrete slab supported by timber piles.

As part of this PD&E Study, a Build Alternative was considered. The proposed Build alternative would provide a single span concrete bridge supported by concrete piles, with two 11-foot-wide travel lane, and 5-foot wide outside shoulders.
