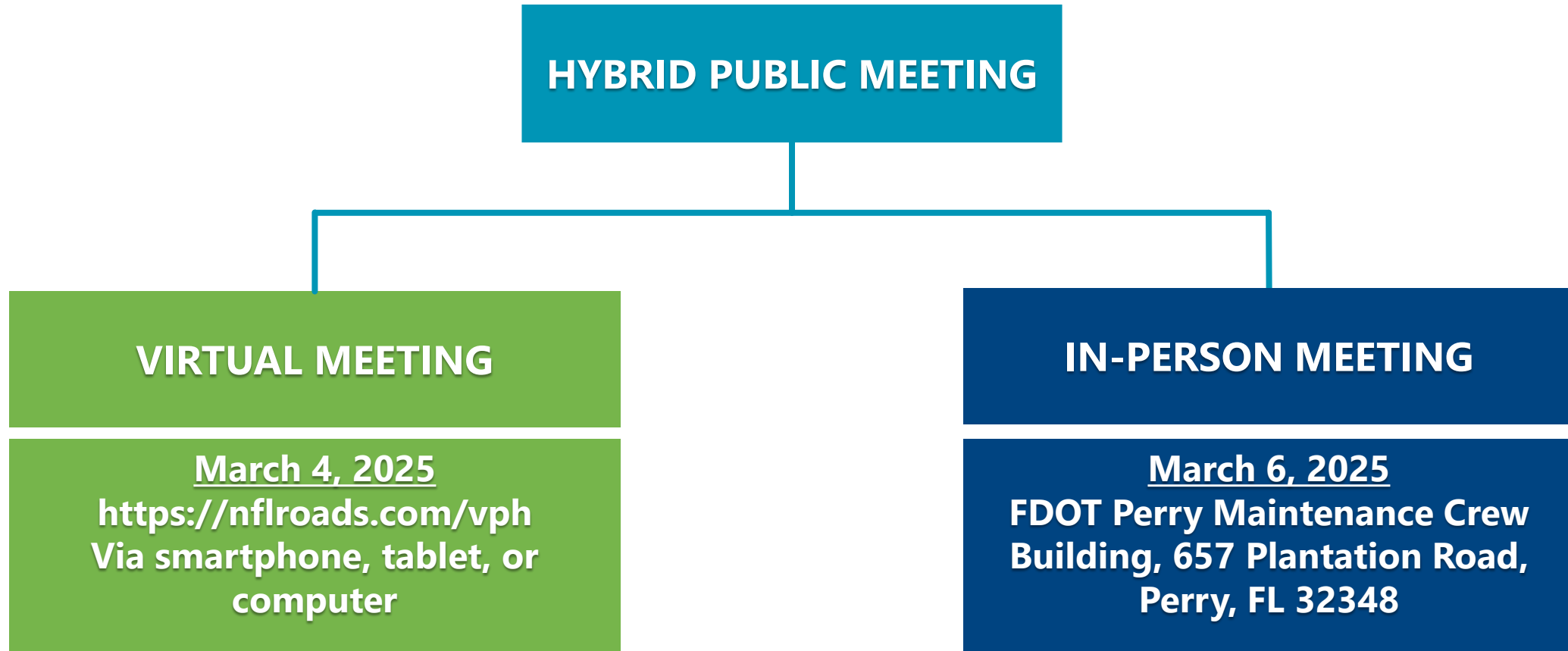

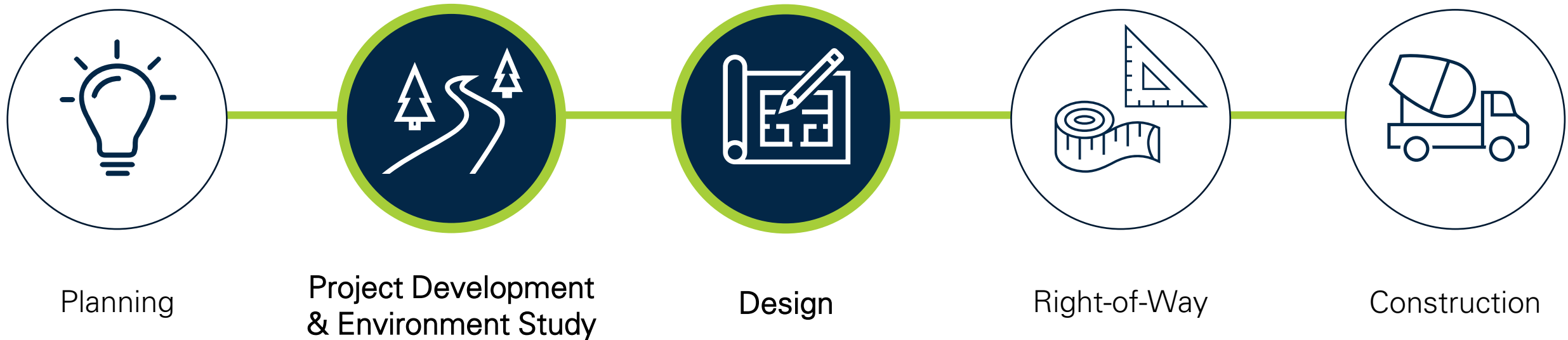

# Project Development Phases

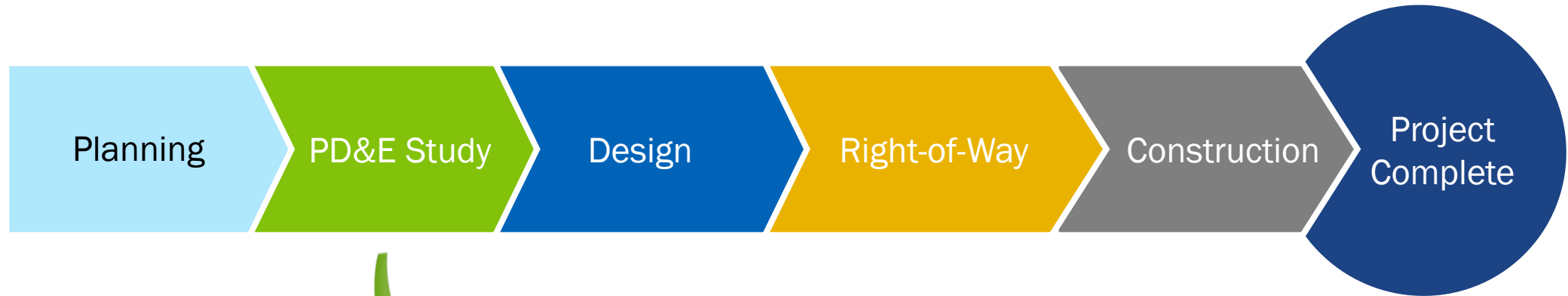

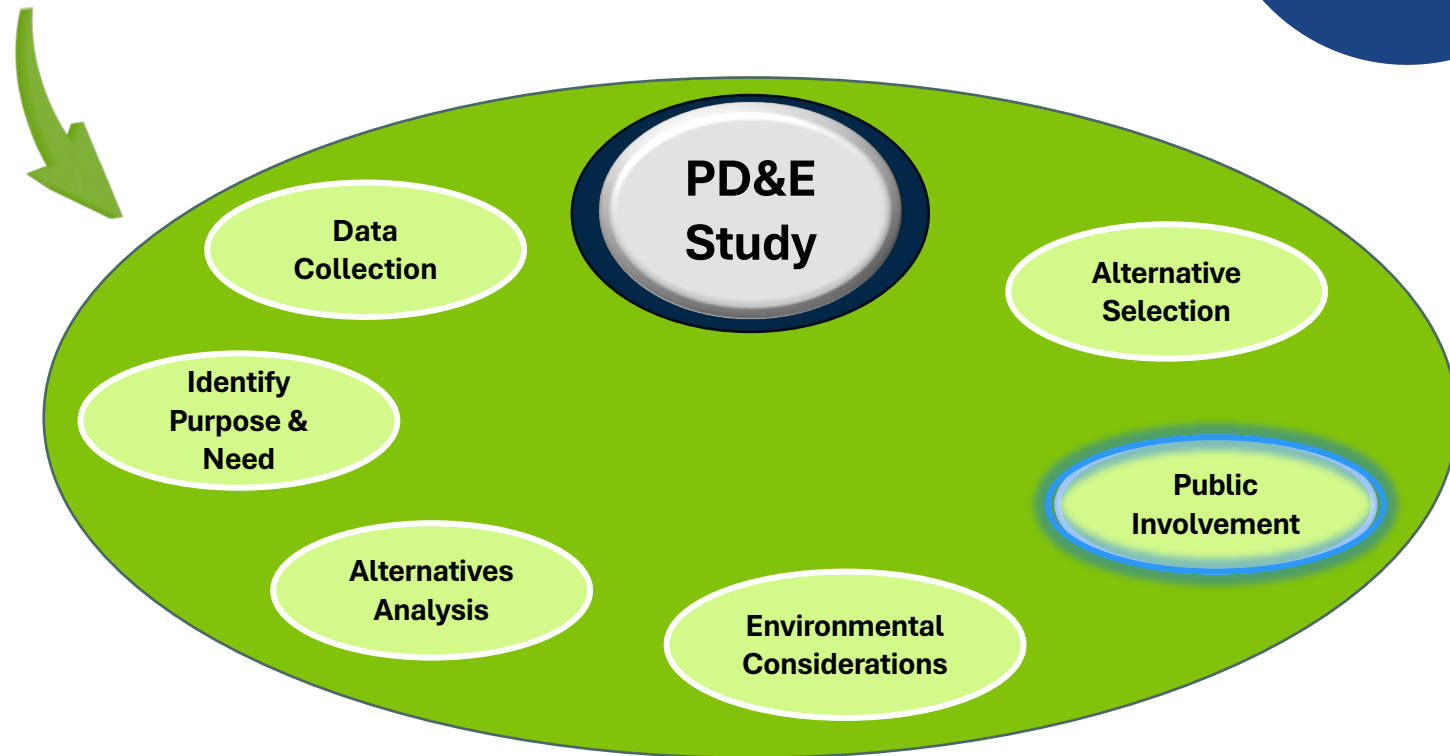
Currently, the Main Street Bridge project is in the PD&E and Design phase.

During the PD&E study, a number of activities are involved, including Data Collection, Purpose and Need Identification, Alternatives Analysis, Environmental Considerations, Public Involvement, and Alternative Selection. Tonight's Public Meeting is part of the public involvement component of the study.



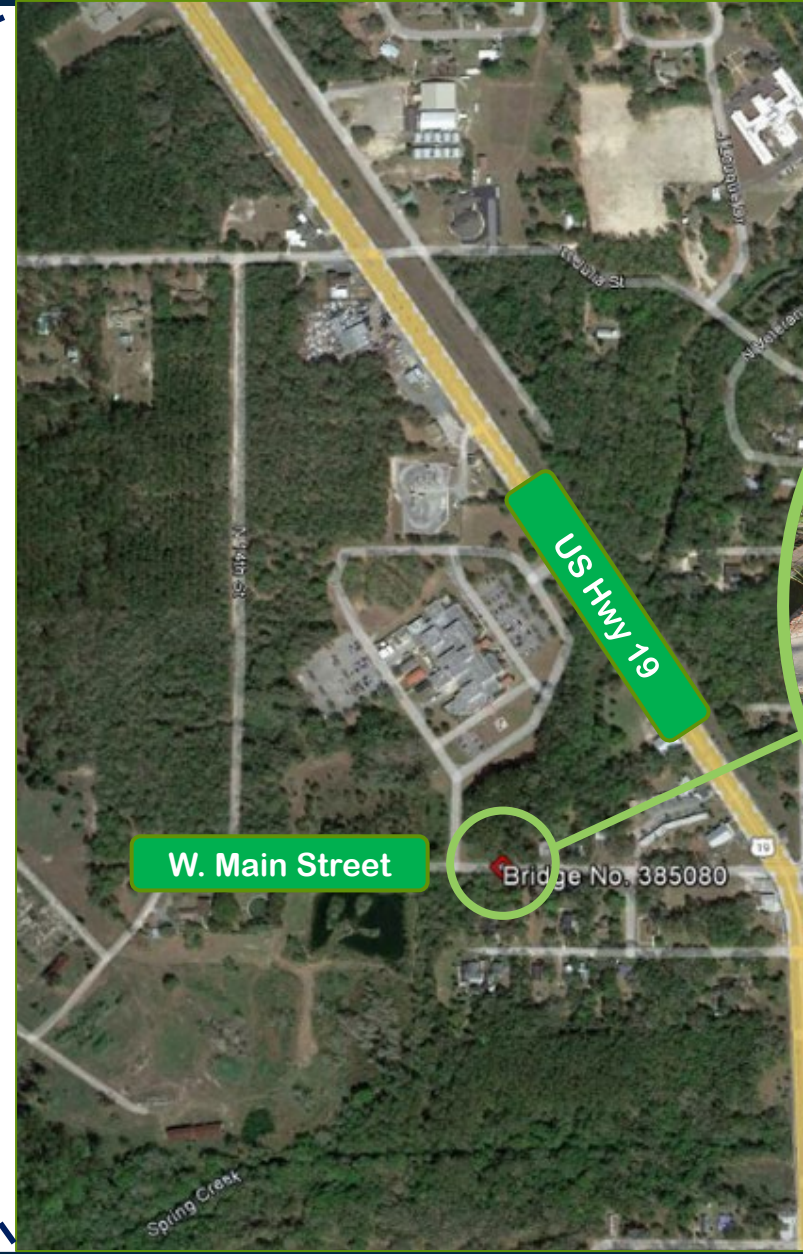
# Project Location

Main Street Bridge Replacement over Pimple Creek - Bridge #385080

Financial Management Number: 210870-2



This project is located in Taylor County along Main Street which is an east-west roadway that runs westerly from US Highway 19. The bridge crosses Pimple Creek which is approximately 1-mile northwest of the City of Perry.





# Purpose and Need

The primary need for this project is based on the structural deficiency of the bridge.

- Structural deficiency occurs when a structure has cracks, damage, wear, or other problems that if ignored, could become worse and lead to the structure failing.
- The 2022 FDOT Bridge Management System Inspection Report classified the Main Street bridge at Pimple Creek as "Structurally Deficient"
- The report also rated the deck and substructure in "poor condition."

Without any improvements, the continued deterioration of the bridge will require additional weight restrictions and possible bridge closure to public use.





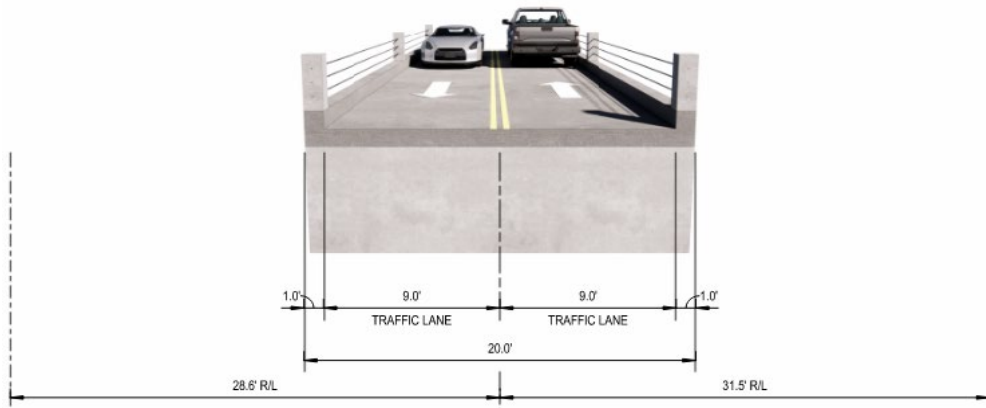
# Existing Main Street Bridge Over Pimple Creek

Existing Main Street Bridge  
Over Pimple Creek



Constructed in 1950, the existing Main Street bridge over Pimple Creek is a two-lane, concrete slab bridge.



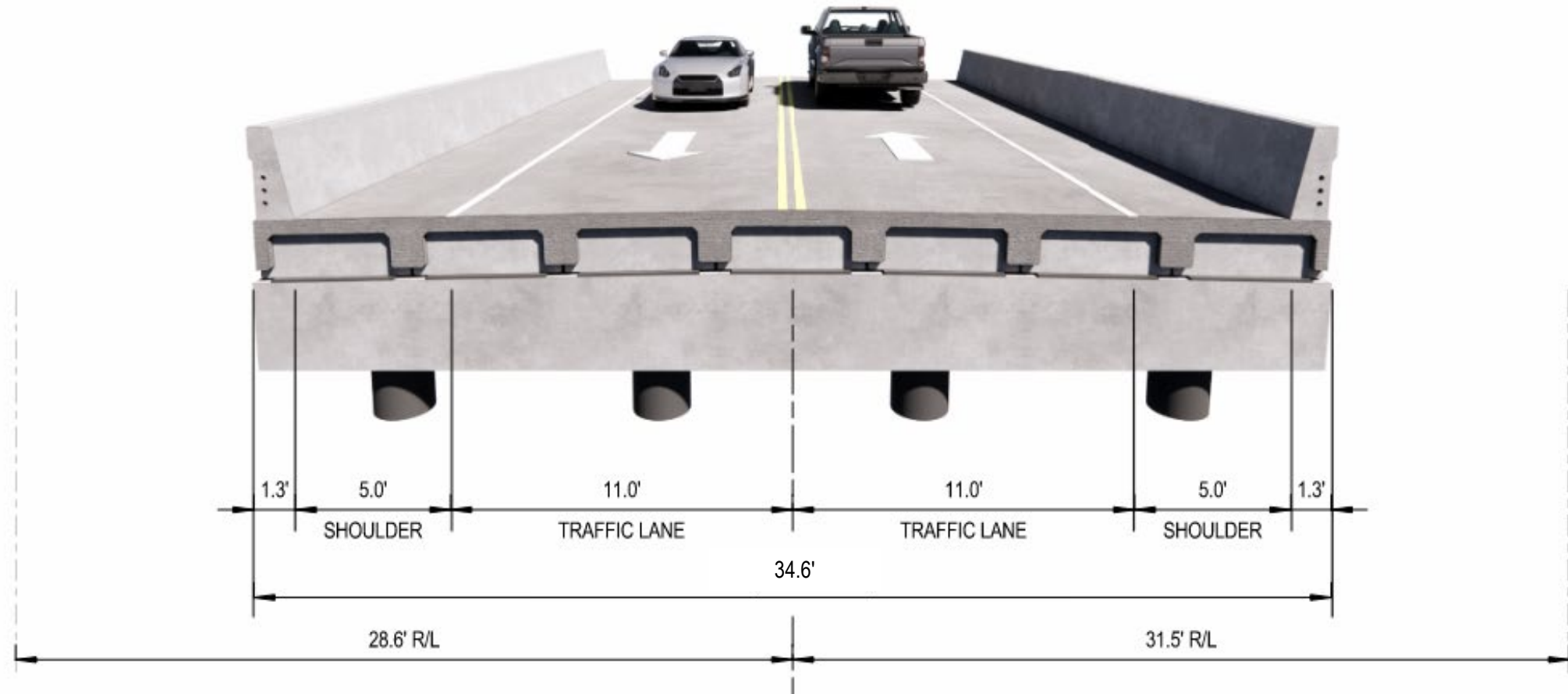
As part of the PD&E Study, two alternatives were analyzed, a No-Build or “Do Nothing Alternative” and a Build Alternative for the Main Street Bridge over Pimple Creek.

The No-Build Alternative would not address the Purpose and Need of this project due to the following:

- No improvements to existing structure would be made
- Bridge will remain as “Structurally Deficient”



# Build Alternative: Single-Span Bridge



As part of this PD&E Study, a Build Alternative was considered. The proposed Build alternative would provide a single span concrete bridge supported by concrete piles, with two 11-foot-wide travel lanes, and 5-foot-wide outside shoulders.



# Temporary Traffic Control Plan

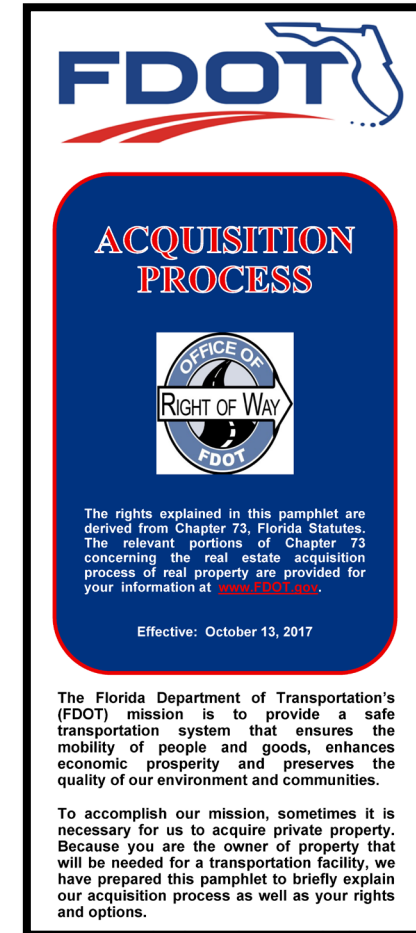

For the duration of construction, the Department proposes to close Main Street to through traffic between US Highway 19 and Doctors Memorial Hospital's South entrance. A detour will be in place to route traffic through Doctors Memorial Hospital's driveway, for a total detour route of approximately 0.83 miles.

No private right-of-way is required (constructed within City Right-of-Way)

- No relocations of families or businesses



*All right-of-way acquisition will be conducted in accordance with Florida Statute 339.09 and section 421.55 and also the Federal Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, commonly known as the Uniform Act.*



Environmental considerations and possible impacts to the environment are important elements of the PD&E Study.

The Proposed Alternative will not result in any adverse impacts to:

- Noise
- Contamination
- Social
- Economic
- Historic and Archaeological Resources



A General permit from the Suwannee River Water Management District and a Nationwide Permit from the U. S. Army Corps of Engineers will be required.

The project will not affect existing floodplain elevations.

- Less than 0.5 acres of wetland impacts
- Encroachments within this project are classified as minimal, not significant

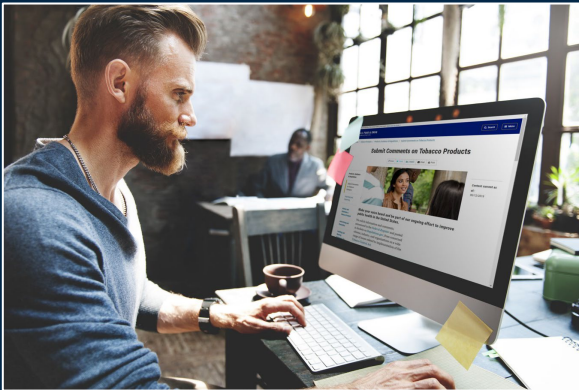
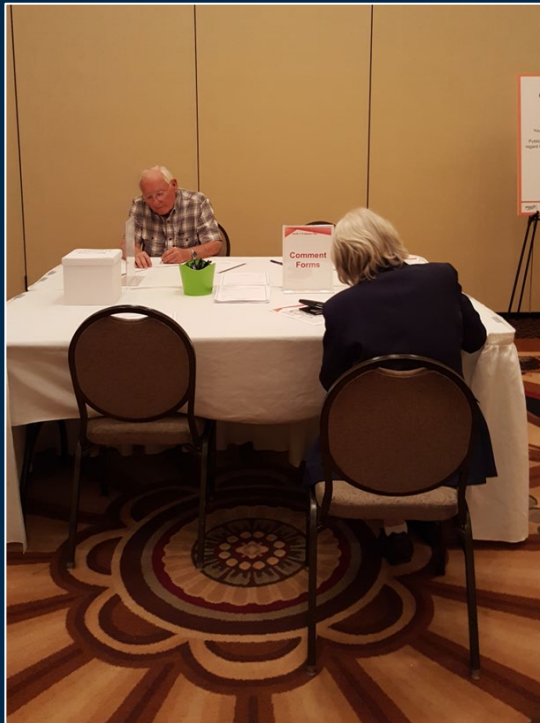

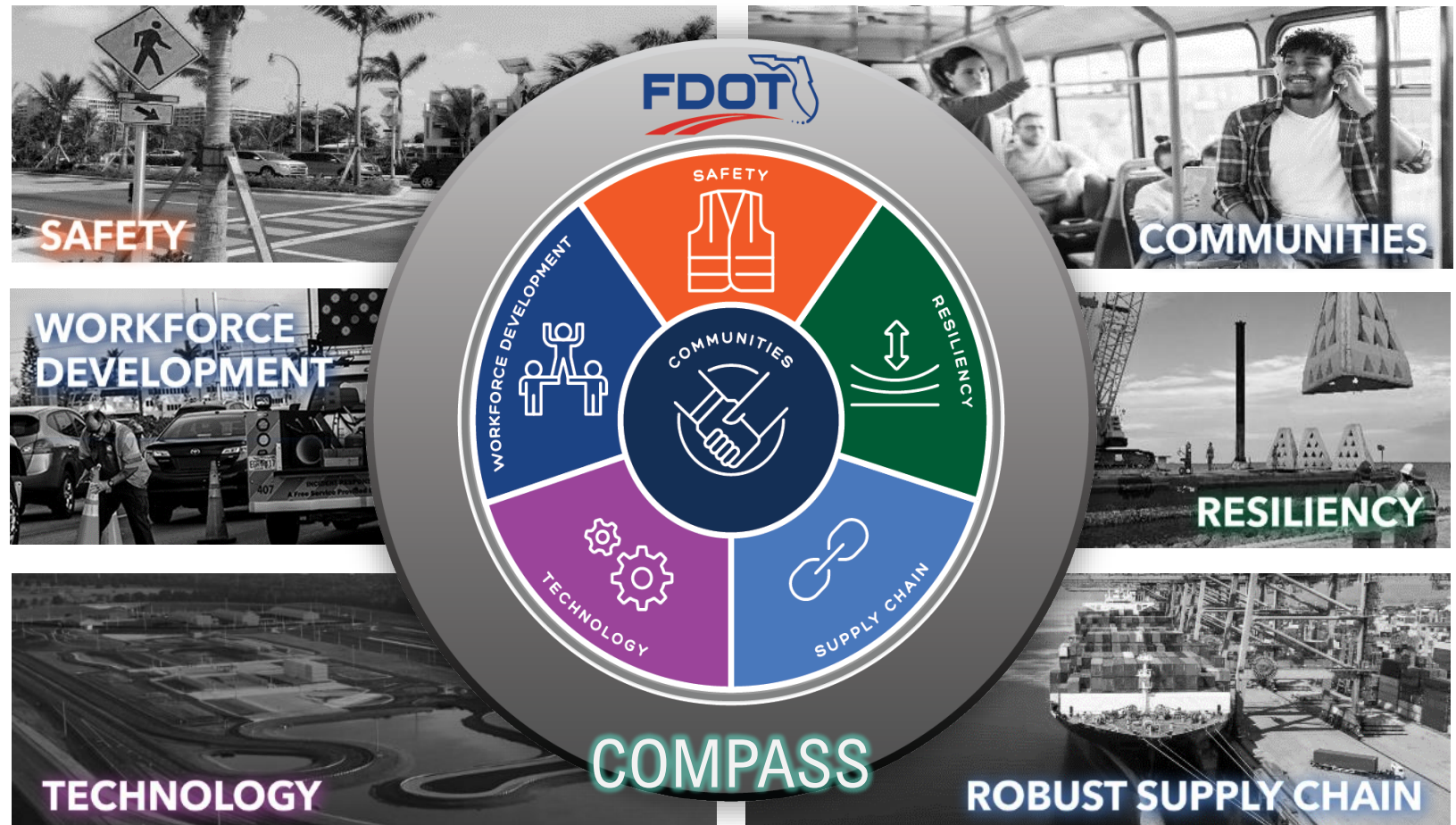
